### IT'S AS EASY AS 1—2—3

- 1** Select your desired membership category, find your household income and note the corresponding monthly fee.
- 2** Complete the membership process at the Welcome Center by bringing with you:
  - A copy of your most recent 1040 Federal Income Tax form or other approved form of income documentation for your household (reduced rate memberships cannot be processed without supporting income documentation)
  - A voided check or debit/credit card for your automatic monthly membership fee
  - A payment method for the pro-rated portion of your monthly membership due that day
- 3** All memberships are forwarded to the Business Office for confirmation. Enjoy your Y membership during a two-week confirmation period. You will be notified only if the monthly fee selected is not supported by your household income or if additional information is needed.

## WHAT DOCUMENTATION IS REQUIRED TO VERIFY MY HOUSEHOLD INCOME?

To process flexible pricing memberships you must provide a copy of your most recent 1040 or 1040EZ and any government assistance for all individuals contributing to the household.

## WHY DOES THE Y NEED MY FEDERAL TAX RETURN?

The federal tax return provides comparable information on household income and allows us to determine membership rates in a fair and consistent way.

## WHAT IF I DO NOT HAVE A 1040 OR 1040EZ?

Please review the options below for a solution regarding your specific circumstance:

- **You are unable to locate your tax form:** Contact your tax preparer or call the IRS at 800-829-1040
- **I did not file taxes last year:** For each income earner who contributes to the household, we require copies of W2s or copies of one month of current pay stubs showing gross income.
- **Your household received government assistance:** Please bring copies of your statements.

## WHAT DOCUMENTATION IS CONSIDERED GOVERNMENT ASSISTANCE?

- Disability statement
- Social Security statement
- Unemployment benefits history
- SNAP, cash assistance, housing and utilities
- Bank statement showing automatic deposit of assistance
